At BaneCare, we understand what an incredibly difficult time this is, and how important communication is to our extended community of residents, family members and staff. As we share the information on how the COVID-19 virus has impacted our facilities, please know that the clinical and administrative teams across our organization are working tirelessly to manage this crisis.

We are taking steps based on guidance from the Centers for Disease Control and Prevention (CDC), the Department of Public Health and the Center for Medicare and Medicaid Services (CMS) to reduce the spread and impact of COVID-19, such as:

- Enhanced infection control precautions including PPE coaches and education, frequent cleaning with specialized cleaning agents, and environmental controls
- Screening residents, staff, and essential visitors for symptoms of COVID-19 or recent travel from high risk locales
- Limitations on visitation and entry of people to the building
- Frequent testing of staff and residents for COVID-19 based on current protocols and availability of tests
- Limitations on communal activities
- Facility-specific mitigating actions will be provided via telephone or email communications

Due to government privacy requirements, we cannot divulge specific information about the individuals who have confirmed or suspected COVID-19, unless they are your family member and you have the necessary permissions to receive such information.

We know you are concerned about your loved one, but it is crucial that we take these measures to reduce the spread of this virus to others. We will contact you directly if your loved one is suspected or diagnosed with COVID-19.
